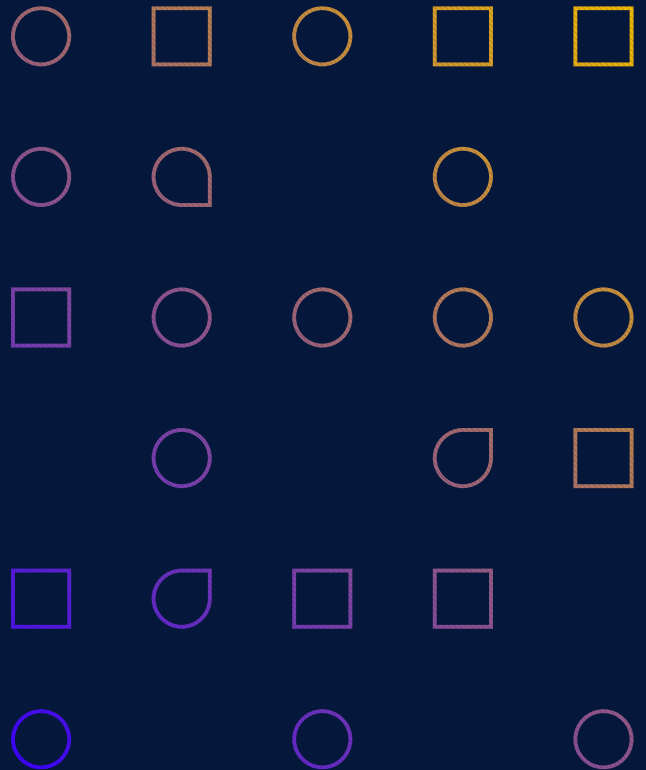

# Proactive, not reactive.

With consistent policies in place, content monitoring becomes deliberate, managed, and defensible rather than ad-hoc.



## Monitor and manage content in place

Achieve visibility into what data your organization is currently storing and managing. Cleanse new occurrences of ROT or stale data. Workflows are initiated for review, action, and disposal.

## Resolve record leakage, disposition, and retention

Remediate sensitive data and reduce data risk in the event of a breach. Identify records/sensitive data for regulatory compliance and proactive eDiscovery savings.

## Create a rich set of metadata

Classify and tag data to create metadata and drive records management, enable business processes, and enhance navigation.

## Rationalize file share structure

Re-structure files based upon classification and analysis results. Map content to file plans, taxonomies and other metadata types.

## Straightforward policy enforcement

Deploy policies on content at rest or in use for quality, health, value and compliance. Augment metadata against business schema and policies. Policy violations are notified to responsible staff.

## Prepare content for migration

Screen for and remediate sensitive data before migration exposes it to search or leaks it to a cloud destination. Reduce storage costs by moving only the content you need.
